RELEASE AND LIABILITY WAIVER

If you are 18 years old or older, you must read and sign the following waiver before doing volunteer work for Hurricane Katrina Relief Project sponsored by the First Baptist Church of Clinton, LA in association with Lakeshore Baptist Church of Lakeshore, MS.

If you are under 18 years of age, a parent or guardian must read and sign the following waiver before doing volunteer work for Hurricane Katrina Relief Project sponsored by the First Baptist Church of Clinton, LA in association with Lakeshore Baptist Church of Lakeshore, MS.

This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 20_____ by _____ (the "Volunteer"), in favor of the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi.

The Volunteer desires to work as a volunteer for the First Baptist Church and/or Lakeshore Baptist Church and engage in the activities related to being a volunteer (the "Activities"). The Volunteer understands that the Activities may include constructing, deconstructing, & rehabilitating residential buildings of Lakeshore, Mississippi, being transported to and from work locations, working at special events, and consuming food and living in accommodations provided for by Lakeshore Baptist Church in Lakeshore, MS.

The Volunteer hereby freely, voluntarily, and without duress executes this Release under the following terms:

1. Release and Waiver. Volunteer does hereby release and forever discharge and hold harmless the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi and their successors and assigns from any and all liability, claims, and demands of whatever kind of nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with Hurricane Katrina Relief Project. Volunteer understands that this Release discharges the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi from any liability or claim that the Volunteer may have against the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi with respect to any bodily injury, personal injury, illness, death, or property damage that may result from Volunteer's Activities with the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi, whether caused by the negligence of the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi or its officers, directors, employees, or agents or otherwise. Volunteer also understands that the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi does not assume any responsibility for, or obligation to, provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. Medical Treatment. Volunteer does hereby release and forever discharge the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in

connection with the Volunteer's Activities with the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi.

3. Assumption of the Risk. The Volunteer understands that the Activities may include work that can be hazardous to the Volunteer, including, but not limited to, construction, loading and unloading, and transportation to and from the work sites, and that food, accommodation, and medical facilities may be donated and beyond the control of the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi. Volunteer hereby expressly and specifically assumes the risk of injury or harm in these activities and releases the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi from all liability for injury, illness, death or property damage resulting from the Activities of the Volunteer's participation with the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi.

4. Insurance. The Volunteer understands that, except as otherwise agreed to by the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi in writing, the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi is not obligated to and does not carry or maintain health, medical, or disability insurance coverage for any Volunteer.

Each Volunteer is expected and encouraged to arrive with medical or health insurance coverage in effect.

5. Photographic Release. Volunteer does hereby grant and convey unto the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi all right, title and interest in any and all photographic images and video or audio recordings made by the First Baptist Church of Clinton, LA and/or Lakeshore Baptist Church of Lakeshore, Mississippi during the Volunteer's Activities with the First Baptist Church of Clinton, LA /or Lakeshore Baptist Church of Lakeshore, Mississippi, including any photographs or recordings.

6. Other. Volunteer expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Mississippi, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Mississippi. Volunteer agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of this Release which shall continue to be enforceable.
